Note 1: Insurance Requirements:

The Licensee shall and hereby does indemnify Limerick County Council against all responsibility in respect to injury of persons or property arising in conjunction with this licence. The minimum indemnity for a single accident shall be €6.5 million.

An Endorsement must accompany each application, confirming that the Applicants Public Liability Policy is extended to provide indemnity to Limerick County Council in respect of any legal liability which may attach to them arising out of the negligence of the Applicant or of their Agents.
